200. TO APPROVE MINUTES OF THE MEETING OF COUNCIL

RESOLVED: The minutes of the meeting Tuesday 05 July May

201. TO RECEIVE THE MINUTES OF THE NEIGHBOURHOOD PLAN COMMITTEE

The minutes of the committee meeting of 21 June were received. A verbal report was also given to members.

RESOLVED: To receive the minutes and verbal report of the Committee.

202. REPORTS FROM COUNTY/DISTRICT COUNCILLORS

Cllr Byron Rhodes provided an update of the Local Plan. The responses to the latest consultation have been considered & categorised. The next phase is to produce the submission draft for the Planning Inspector which will first go out to a 6 week public consultation in October or November. The submission draft & public comments will be sent to the Planning Inspector. Melton Borough Council are tentatively working to a Spring 2017 public enquiry (but the Planning Inspector is in control of this date) followed by adoption at the end of 2017.

Melton must demonstrate a 5 year land supply in the Local Plan, less than that will not carry weight. The Planning Inspector could reject the Local Plan without that key 5 year land supply. Planning applications in village locations are often outline which don't count toward a 5 year land supply as there are no time frames attached. Only 500 houses have been built in the last 5 years; 245 new houses per year need to be built.

There is a full Council meeting at Melton on 01 September to agree how to proceed with the categorisation of villages based upon their sustainability. A change of policy is anticipated with the number of categories likely to reduce. Village categorisation has been problematic as a number of villages identified as sustainable do not have capacity at the school. Following 01 September meeting Wymondham will be advised of their housing allocation.

Cllr. Matthew Williams asked how Wymondham & Edmondthorpe's Neighbourhood Plan will integrate with the Local Plan. Cllr. Byron Rhodes believed the Neighbourhood Plan referendum could still go ahead but if there were issues with the Local Plan then the Neighbourhood Plan

could be impacted. A Neighbourhood Plan has weight but only in conjunction with the Local Plan. In theory, the Local Plan & Wymondham & Edmondthorpe's Neighbourhood Plan could be adopted by Melton Borough Council at the same meeting.

Leicestershire County Council has responded to Lincolnshire County Council over the South Witham quarry extension stating that it does not have an objection to the extension but asks for a condition that all quarry related HGV operators use the southern entrance.

Cllr. Byron Rhodes & MP Marcus Jones, for Communities & Local Government are meeting with Treasury officials in September to discuss the on-going issue of how Leicestershire County Council's funding is calculated compared to other County Councils.

Cllr. Byron Rhodes was thanked for his report

RESOLVED: To receive the above report.

203. REPORTS FROM REPRESENTATIVES ON OUTSIDE BODIES AND MEETINGS

No reports have been received. However, it was noted that a property had been broken into in Edmondthorpe. This information came via the Neighbourhood Watch network.

204. PUBLIC PARTICIPATION

- a) Public Speaking Protocol The Clerk had received no applications to speak.
- b) The meeting was suspended to allow members of the public to make representations about any item not on the agenda (parishioners time).

Meeting suspended at 8.20pm

Cllr Matthew Williams asked when the community project fund would be launched in the Wymondthorpe & Edmondthorpe Journal. The new Clerk to look into.

Cllr Pat Peters asked for an update on the registration of the Village Green. Anyone could apply for a designation of this area but more investigative work is required to differentiate between the use of the Village Green 'by right' or 'as a right'. There would be a cost to the Parish Council if the registration was pursued. It was suggested the Neighbourhood Plan group Committee take on the research & bring their findings to Parish Council to agree next steps.

The meeting resumed at 8.30pm

Installation of a 25m high lattice tower supporting 3no. antennas and 2no. 600mm diameter dishes, along with 3no. equipment cabinets and 1no. electrical cabinet at ground level. The proposed installation would introduce 2G, 3G and 4G coverage on the Telefonica (O2) network within the local area.

RESOLVED: Council to object to this application because there is an existing mast near-by so is it appropriate for a new mast to be installed when dual use of masts is being encouraged. There

is also concern at the proximity of the nursery & school. Also enquire whether any archaeological assessment has been made on the Crusader's Chapel.

This application was included within the Clerk's report; due to its receipt after the publication of the agenda but was discussed & minuted with other applications for consent to develop.

County Matter Application Consultation PL/0074/16

Proposed Eastern and Western extension to South Witham Quarry.

This item was discussed after minute 202 but written up as per the agenda running order.

The Parish Council had requested assistance from Leicestershire County Council Highways with this application as there was concern that the extension would see an uplift in quarry traffic through Wymondham & Edmondthorpe. Leicestershire County Council has responded accordingly & is detailed under minute 202. A special quarry group has set up within Wymondham & Edmondthorpe to protest against the use of local roads by HGV quarry traffic.

The Parish Council believe the use of the southern exit & entrance from the A1 is the obvious choice for all HGV quarry traffic.

RESOLVED: To respond to the consultation asking for a condition that all HGV quarry traffic use only the southern exit & entrance from the A1.
